Contract Terms and Conditions

I/We understand that:

- The registration fee is required by the second playing date. Registration fees can be paid by Chq or Cash to the registrar, by going to a Bank of Queensland and completing a third party deposit slip or by our **Preferred Method of Internet Transfer (BSB: 126547 & A/c 01034829, please put player's name in description)**. We also accept Kidsport Vouchers for eligible members, please contact our registrar for details. Please also note that fees are Non-Refundable.
- That all care is taken in training sessions and the child/player must abide by the behaviour rules of the club.
- That playing, observing, learning or training in basketball and participating in any activity carried out by the club, inherently involves risk, and in participating or undertaking in these activities, I/we (Parent, Guardian & player) do so at our own risk.
- As a condition of admission to membership of the club, its office bearers, officials, coaches, managers, umpires, members and/or agents, are absolved from any liability arising from injury or damage howsoever caused to players and spectators.
- We agree that nothing in this agreement purports to exclude any liability that may be owed by the club or Association and their representatives pursuant to the provisions of any relevant statutory acts covering these activities. To the extent that any part of this agreement may contravene any of the statutory acts, I agree that part of the agreement may be severed and rendered void but the rest of the agreement will remain valid and continue to have effect.
- All siblings of the registered players must be under constant supervision by the parent/guardian and they at all times will be supervised during games and training, so as not to disrupt any club activities or to cause injury to others.
- When required, we will assist the club by participating in rosters, scoring, umpiring and providing assistance to set up and clean up courts and facilities after use.
- The basketball shirt remains the property of the club and will only be issued to the player once part payment of the annual fees is paid to the club. Lost or damaged shirts will be charged to the player at replacement cost.
